

# CERTIFICATION

## **PEFC (Programme for the Endorsement of Forest Certification schemes)**

The certification system is based on the international decisions of the Rio Conference on the Environment (1992), the actual foundation took place in Paris in 2002. The primary goal of PEFC is sustainable forest management with a focus on economic, ecological and social standards.

## **FSC® (Forest Stewardship Council®)**

The FSC - founded in 1993 as a result of the Rio Earth Summit - is a non-governmental, non-profit organisation. It brings together entrepreneurs from the timber and forestry industry, environmental associations, trade unions, representatives of civil society and indigenous peoples. The most important goal of the FSC is to ensure that the forests of our planet are used in a more environmentally friendly, socially acceptable and economically viable manner.

## **EUTR (European Timber Trade Regulation)**

This regulation prohibits the import of illegally harvested timber and products made from it. The legal origin of wood must be fully documented by the importer at every step of the supply chain.

## **SVLK (Timber Legality Assurance System)**

The SVLK seal of approval for legally harvested timber is the certification programme for the forestry product chain adopted by Indonesia in 2009. The system guarantees that the exported timber products are legal and their place of origin is guaranteed traceable. SVLK is to ensure that only wood from sources of origin that are legal under Indonesian regulations is purchased and processed. These regulations cover aspects such as concessions, harvesting, transport and processing for the industry. The SVLK standard is an important step in the efforts to achieve full sustainability certification in accordance with SFM (Sustainable Forest Management).

## **FLEGT (Forest Law Enforcement, Governance and Trade)**

FLEGT is a European Union action plan that has been in place since 2003. The Agreement aims to increase the availability of legal and ideally sustainable timber and timber products worldwide through forest governance and forest law enforcement. Illegal felling is combated through FLEGT, with the EU providing assistance to countries in the process, for example in developing their own forest legislation and establishing forest management.
